



### **CRITERIA for Judging NCAMES HOF Nominees for Induction into the HOF:**

When reviewing the applications and essays for the NCAMES Hall of Fame, the Selection Committee should use the checklist below as guidelines to determine the eligibility of the nominees for induction into the NCAMES HOF.

- Worked for a NCAMES member City or Town
  - i. How many years in the Electric industry
  - ii. How many years working for the NCAMES City or Town
- Served NCAMES as the following (Choose all that apply and include number of years served for each):
  - i. NCAMES Safety and Training Committee Member
  - ii. NCAMES Safety and Training Committee Officer
  - iii. NCAMES Board Member/Officer
  - iv. Electricities School Instructor/Trainer for Lineman/Meter/Substation/Etc. schools
  - v. NCAMES Rodeo Judge
  - vi. NCAMES Rodeo Competitor (Journeyman and/or Apprentice)
  - vii. Lineman/Meter/ Substation Committee Members
  - viii. Volunteer for Mutual Aid for Storms, Hurricanes, Ice Storms, Etc.
  - ix. Other Safety Committees Served for NCAMES or their Town (e.g. APPA committee)
  - x. Any Community Service that has benefited/promoted NCAMES
- Has this person been a Positive Role Model/Influence for other members of NCAMES?
- What has this person done to advance and/or improve NCAMES?
- How has this person gone above and beyond their normal duties to further NCAMES?

Anyone that is a NCAMES member and meets these any of these guidelines is eligible to be nominated for consideration for the NCAMES Hall of Fame. All completed applications will be reviewed. All applicants that are not selected for induction into the HOF and want to be considered for the following year, can re-apply the following year. Applications will not be held over from year to year, so reapplication is necessary for reconsideration.

### **Hall of Fame Committee Voting Guidelines:**

When the Hall of Fame Committee meets, it may be necessary to have several votes to select the 3 to 5 inductees into the Hall of Fame. If there are several applications, after the first vote it may be necessary to eliminate all applications that did not receive votes and re-vote on the applications that did receive votes. Using this process of elimination, the committee should be able to select 3 to 5 inductees for the Hall of Fame using one or more elimination rounds of voting (if needed). All nominees receiving seventy percent (70%) of the votes or more [meaning 5 or more of the 7 HOF committee members voting in favor of an individual nominee] will be inducted into the Hall of Fame. Each HOF committee member will have four votes during each round of voting, but can only use one vote per nominee per round of voting. For example, if there are 10 nominees, a committee member may vote for four different nominees of the 10, but shall not use more than one vote per nominee.
